The Council reviewed the draft of the leaf and limb ordinance. The Council defined a load of yard trimmings as one swacar or six cubic yards. Limbs should be trimmed to six feet long and be no more than five inches in diameter. An unscheduled service exceeding a load shall be \$150. The ordinance will be sent to the attorney for review and presented at the April regular council meeting.
